- 3. Which of the following applications you are available to assess:
  - Short films (August 2023 only)
  - Feature development and/or production (year-round)
  - Career development (year-round)

In addition to the above, please let us know if you are able to assess filmmaker applications in the Welsh language.

#### **Access Support**

Candidates must be over 18 years of age but do not need to be born, based or currently working in Wales.

Ffilm Cymru is not a licensed sponsor for VISAs and as such you must already have the Right to Work in the UK in order to undertake this role.

Due to potential conflicts of interest, we cannot work with freelance assessors who:

- are a current staff or board member of Ffilm Cymru Wales, Arts Council Wales or the BFI
- have a lead role on an active award from Ffilm Cymru
  Wales across any of the filmmaking funds they would be
  assessing OR be planning to apply for any of these funds
  between August 2023 and March 2024

Assessors will be required to declare conflicts of interest before undertaking any assessing work.

- Specific knowledge of animation
- Ability to engage with creative work in the Welsh language
- Experience lead producing a short or feature film
- Experience in sales or distribution
- Experience in film talent development
